

## **CALL FOR PAPERS**

The *NIALS Journal of Intellectual Property [NJIP]* is a bi-annual peer-review journal of the Nigerian Institute of Advanced Legal Studies, which publishes original contributions by learned scholars, practitioners, jurists and policy makers in the field of Intellectual Property. The Journal aims at promoting existing and new knowledge, ideas and concepts towards developing intellectual property jurisprudence and policy for use by governments, companies and organizations, both international and regional. The Journal aims at establishing a platform for discussion of practical legal problems in the development of intellectual property and the interaction of the legislature, the courts and institutions, both public and private in the enunciation of the law and policy.

Considering the rising profile of intellectual property as a multi-disciplinary subject, NJIP breaks new ground in scholarship as the first referred journal in the field of intellectual property rights published in Nigeria and the African continent.

The Advisory Editorial Board of the Journal is multi-national comprising experts in the field and jurists who have been nominated to serve on the Board of the NJIP.

The Editorial Committee seeks original scholarship to be published in the next edition of the Journal. Articles should explore the depths of the subject of discourse within the relevant contexts of the wider socio-economic, cultural, technological and political developments and may not be confined to legalism. In addition to articles, book reviews, research findings and case studies, case reviews and opinions are accepted.

### ***EDITORIAL INFORMATION AND GUIDELINES FOR SUBMISSION OF ARTICLES***

#### **Length of the Article and Citation Style**

Original articles should be accompanied by a structured abstract of not more than 200 words on a separate page.

Original manuscripts of articles are should generally be up to 3000 words in length and Analysis of not more than 2000 words; a double-spaced page with one inch margins using regular 12 fonts size. Longer manuscripts will be considered but we reserve the right to edit all manuscripts for length.

#### **Format**

Authors should submit a copy of manuscript in Microsoft Word, in English. Manuscripts may also be submitted as attachments to electronic mail.

#### **Citation**

Articles should conform to the *Uniform System of Citation* (17<sup>th</sup> ed.), i.e. *Donald E. Bierderman & Others, "Law and Business of the Entertainment Industries", 3<sup>rd</sup> Ed., Praeger Publishers at p. 1-5*. Author should provide a short biographical note in not more than fifty (50) words. And please indicate Intellectual Property speciality area in which you research or practice.

#### **Deadline**

Deadline for submission of written materials to the two editions of the Journal shall be March and October of each year. Articles that are not processed on time for this edition will be published in the next edition.
